Public Policy

A lifelong pay gap between men and women results in women having significantly less income than men during their retirement years. Women often have a disproportionate share of family caregiving responsibilities which often takes them out of the paid workforce. Women are more likely to move in and out of the workforce and are more likely than men to work part-time. This results in accumulating less savings and may result in less access to employer-sponsored retirement plans. Moreover, many women work in industries or occupations that do not offer 401K plans or other defined contribution plans thus limiting their opportunities to invest in their retirement.



Some Efforts AAUW Supports that Impact this Issue

The Healthy Families Act (H.R. 2465/S. 1195) - would provide full-time employees the right to earn up to 7 job-protected paid sick days a year. These days could be used for their own medical needs or to care for a sick family member.

The Family and Medical Insurance Leave Act - FAMILY Act (H.R. 804/S.248) - would create a national self-funding paid family and medical leave insurance program.

The Paycheck Fairness Act - (H.R.7/S.205) - would strengthen The Equal Pay Act of 1963 by closing loopholes that allow employers to justify paying workers unfairly, creating more robust remedies for those who have suffered discrimination, preventing employers from retaliating against workers who discuss or disclose their wages, prohibiting employers from relying on salary history to set wages and providing training, technical assistance, data collection and research. This Bill has passed in the House of Representatives but has stalled in the Senate.

Diversity, Equity, & Inclusion (DEI)

Last month we defined the frequently used terms of Diversity, Equity, and Inclusion. This time we go a bit further from National's AAUW Toolkit.

Diversity vs. Inclusion

Diversity refers to characteristics, the dimensions that make each of us unique. <u>Inclusion</u> entails behaviors and actions that make us feel welcomed or not. An environment that creates a sense of belonging, where everyone feels welcomed and included, is essential for the success of diversity efforts.

To be truly inclusive, we often have to change the culture — and culture shifts can make people uncomfortable or give the sense that they are losing something. But that is absolutely not the case. In fact, the exact opposite is true: Research suggests that in environments where people feel supported, welcomed, respected and valued are actually more productive; everyone feels a greater connection to the organization's mission.

Inclusion vs. Belonging


So, if diversity means the characteristics that make us unique, and inclusion refers to behaviors and actions, then what is belonging? And why is it important?

<u>Belonging</u> is feeling like you are a part of something, that you actually matter. It isn't necessarily about being liked — but rather being needed.

AAUW needs all of these things together — diversity, inclusion, and belonging — for our branches to continue to grow and thrive.

Great Read From DEI

This month's great read is *Everything I Never Told You* by Celeste Ng. The book was published in 2014 and was a bestseller. In addition to recommending this book, we are featuring Ms. Ng as her work focuses on issues in diversity




Ng's third novel, *Our Missing Hearts*, was published in October 2022. This is Amazon's synopsis:

Twelve-year-old Bird Gardner lives a quiet existence with his loving but broken father, a former linguist who now shelves books in a university library. Bird knows to not ask too many questions, stand out too much, or stray too far. For a decade, their lives have been governed by laws written to preserve "American culture" in the wake of years of economic instability and violence. To keep the peace and restore prosperity, the authorities are now allowed to relocate children of dissidents, especially those of Asian origin, and libraries have been forced to remove books seen as unpatriotic—including the work of Bird's mother, Margaret, a Chinese American poet who left the family



when he was nine years old. Bird has grown up disavowing his mother and her poems; he doesn't know her work or what happened to her, and he knows he shouldn't wonder. But when he receives a mysterious letter containing only a cryptic drawing, he is pulled into a quest to find her.
