## The Future of our Branch

**Strategic planning** is the process an organization follows to define its direction. The purpose of strategic planning is to specify organizational goals and to create a plan to achieve them. The process requires stepping back from day-to-day operations to consider what organizational priorities should be. Strategic planning has its roots in the business world, but the process is now applied effectively in many areas of endeavor, including non-profit organizations such as AAUW.

Our branch's current plan was developed in 2017 under the leadership of Jacquie Latzer and Susan Gold. Although it has guided our mission-driven work, it needs to be updated to keep our activities relevant to societal changes. Rather than create a plan from scratch, our strategic planning process will review and revise the current plan.

Co-Presidents-elect Anne Sobocinski and Linda Carpenter are now launching branch efforts to update our strategic plan. Their first step is to constitute a Strategic Planning Committee. In addition to the Executive Committee, Anne and Linda are extending an invitation to any member who wants to contribute to the future of our branch to serve on the committee.

The committee's work will begin in January 2022 and finish by the end of March, so participation will be time-bound. As work on the plan progresses, all branch members will have opportunities to provide input to the committee and suggest goals and action steps for the plan. Anne and Linda are hoping for broad participation in the planning process, so please contact either of them if you would like to join the committee or if you

have ideas about the process or content of the plan...the future of our branch depends on all of us.

## **Members Who Make Our Branch Work**


### **Public Policy**

Public policy is about working for and supporting those policies that affect our people in our neighborhoods, states, and nation. AAUW is very political, but NOT partisan. Whether you vote Republican, Democrat, Independent or some other party, you can still support what is good for our people. It is writing emails and letters, making phone calls and visiting our legislators to remind them that AAUW wants equal pay for equal work, a higher minimum wage for all people, especially women, and health care for all women so that they may be in charge of their own bodies. We also help with voter registration drives, and support getting out the vote with fair elections and fair voting laws.

To these ends, the Public Policy Chair keeps an eye on all bills coming before the Florida legislature and guides her branch to support those that would benefit the people of Florida. This involves participation in Lobby Days, where we go up to Tallahassee and visit the Capitol, talking with those legislators from our districts and encouraging them to get behind legislation we support.

I grew up in northern New Jersey right across from New York City. I became an elementary school teacher. I married a Texan in 1970 and we had a so n in 1977. We moved to Florida in 1971. We lived north of Tampa in Land O' Lakes in Pasco County. In 1986 I received my M.A. in Guidance and Counseling, working as a middle school counselor until 2000. In 1989 my husband died. My son and I went through his teen years together. without killing each other. In 2000 I married Keith Bonn. We lived in Illinois for 3 years until he retired. Villages. I worked 6 more years as a school counselor in Wildwood Elementary School. I joined AAUW in 2009 right after I retired.






## **Great Read from the Diversity Committee**

The unforgettable story of four orphans who travel the Mississippi River on a life-changing odyssey during the Great Depression.









### **Singles Group**



Nine members of our Singles group traveled to Leesburg, Florida to tour the Mote-Morris House and enjoy a social lunch. We met at the historic, late Victorian home at 1195 W. Magnolia Street, an attractive park-like setting. Our guide was Mr. Morris, a member of the last family to live in this home, so we had some special stories to hear. The house is open for tours on the 2<sup>nd</sup> and 4<sup>th</sup> Saturdays of the month; the

admission is free, but donations are welcome. After the tour, we made our way to Naples Restaurant at 1107 W. North Blvd for a tasty Italian lunch.

Leesburg was settled in 1857 and incorporated in 1875. Edward Mote build this home in 1892 at the cost of about \$9000. It is an attractive two-story home with a 4-story turret which provides a wonderful view of the area. The house was sold to John Morris in 1918. The original home was at 1021 W. Main Street but was moved to its present location on September 1, 1990. It was placed on the National Register of Historic Places in 1974 and is one of the few remaining original homes in Leesburg.

The house suffered a devastating fire February 20, 2018, with extensive damage. Restoration work was done by Evergreen Construction of Lake County and all subcontractors were also from Lake County. Much of the replacement lumber had to be hand milled as the original lumber was a different size than the lumber we used today. Rooms were decorated by local businesses in keeping with the time period. Many of the items were original or donated by Leesburg residents.



Mr. Morris told of sharing a large second floor bedroom with his two brothers and noting which stairs squeaked, as they would climb them after curfew. Their sister had a room of her own. The four siblings all continue to reside in Florida. Some of us ventured up the turret stairways and were greeting with a beautiful view of the grounds and gazebo!

Learning the history of our area gives me a deeper understanding of my adopted home in Florida.
